When you enter at the website, you may be asked to consent to receive promotional e-mails and reminders for upcoming promotions and information about Sponsor. Consenting to receive such e-mails is optional and does not have to be agreed to in order to be eligible to enter the Giveaway and does not improve your chances of winning. Except where prohibited, participation in the Giveaway constitutes your consent to Sponsor’s use of your name, likeness, entry, and state of residence for promotional purposes in any and all media, including

7. **SELECTION AND NOTIFICATION OF POTENTIAL WINNER:** All entrants making Eligible Purchases during the Giveaway Period will be selected as winners.
